2019 - 2020

Providence Academy is a registered non-profit organization, financially self-supporting. Operating costs are covered by parent's fees. Reductions will be applied for families of 2 children or more attending the Providence Academy at the same time.

1. Upon registration, parents pay \$1000 per child for the 2019-2020 school year as a deposit
2. This non-refundable amount is due no later than January 31st 2019. It reserves a place at the Providence Academy and covers the processing of admission formalities and the administration of the entrance examination, if any.
3. Tuition fees do not cover the cost of the following items: textbooks, school supplies, student account, school uniform, optional charges which are: educational daycare before and after school, hot meal, tutoring, etc. These additional fees are paid at the beginning of the school year.
4. The invoice and the statement account will be delivered electronically to parents.
5. Parents may submit post-dated checks payable to the Providence Academy in the method described above (Table I) or as approved by the director.
6. Cash is accepted. Payments are also accepted with "Plastic" via FreshBooks (your electronic invoice) using Visa or Mastercard, American Express or Debit (fee applies).
7. An additional 2% fee for late payment and \$40 per returned cheque.

Regulations on the withdrawal or refusal of admission

1) Withdrawal of the student or denial of admission
- The direction of Providence Academy reserves the right to refuse the admission or to remove any student whose behavior is inappropriate, that does not meet all school rules set by the Providence Academy or who fails his/her school year. Such decision will be submitted to the Board of Directors and any confirmation of this decision is final and without appeal.
- The direction of Providence Academy reserves the right to refuse admission or to remove any student whose parents do not adhere to the educational philosophy of the Academy or do not meet all school rules. Such decision will be submitted to the Board of Directors and any confirmation of this decision is final and without appeal.
